1 in 3 Vlog Guide

DIRECTIONS: For this activity, complete the following questions and steps in order to prepare for providing 3 points of view about your personal reactions to mass incarceration by recording and producing a 5 minute vlog. The goal is to read/research from the online resources, reflect on your initial responses to mass incarcerations, and then apply the information to analyze and express your new reaction. Use the online resources listed at the end of this document, and then carefully read and complete each step below.

Part 1: Online Resource Responses -

1. What is mass incarceration?

Mass incarceration explains the social inequalities in the criminal justice system given the US has the highest number of individuals incarcerated than the rest of the world, and it disproprotionately discriminates against people of color.

2. What caused the prison population to grow rapidly high?
